Founded in August 2025, Fitch Vanson Endeavours Ltd delivers a multi-faceted range of services tailored to support lean operations, particularly in the gig economy. Our flexible, cost-effective solutions span:

Client Pipeline

Currently onboarding two new clients to commence services in October 2025:

1. **Sports Coach**
 - Services: Admin, tech, diary & website support
 - Revenue: approx. **£460/month**
2. **Medico-legal Client**
 - Services: Field officer support for evidence collection
 - Revenue: approx. **£1,120/month**

Medium-Term Growth Plans (Years 2-5)

- **Key Nest Services:** Smart locker system for property key management. It will require a spend of £1,050 for the smart locker system, but projected revenue at the low end would be **£2,000** per month.
- **Money Transfer Hub:** In-person services (requires FCA licence) – We aim to serve as a hub for multiple money transfer firms, earning commission on money transfers. The FCA licence will cost £150.00, however, the Money Transfer partner will provide equipment, software, training and advertising support. We aim is to earn approximately **£1,200** per month in commission from various money transfer firms.
- **Legal Support App:** We will develop an app to provide affordable legal support for startups & individuals. We anticipate a high-volume of orders due the cost per unit model we will adopt. Our pricing comes in 10 times cheaper per unit compared to traditional law firms. We aim to charge £2.50 per unit of work equating to 6 minutes per unit. Our target is 60 units per day, with a projected revenue of **£3,000** per month.

12-month financial projections

These projections are based on our current cashflow, including revenue from the two new clients once they are onboarded. We estimate that our expenditure will drop to approx. £500.00 per month once fuel costs are eliminated through the use of electric vehicles. See table below:
